- b. Public Works Report: Richard Wheatly, who is with public works was asked by Vice Mayor Scott about the wells that they are trying to get a grant for. Richard reported that he believed they will be up Indian Canyon. He also reported that we will have to wait until the temperature is above 50 degrees to get the pavement laid on Kaibab Dr. We are still waiting for the material to finish the levy.
- 4. Town Office Updates: Report from Town Clerk: Tracy Stumpf Reported that at the start of the new year they will be doing some training to get the Credit Cards back in house. There were some questions on when to close for the Christmas Eve and New Years Eve. Council left that up to her. The website is up and running. It is user friendly with lots of help form the company. There have been 14,148 views this month. Liz form Kairos stopped by to go over the insurance. It might be hard to get new insurance because of the claims we had last year. We will look into more. Going through the files we have found out that there are a lot of people who have not signed certain forms. At the new year the office will have each employee come in and sign those forms again, as a reminder. The office has been working on how to solve the issue with the comp time. There will be a work meeting to go over this and try and figure it out so we can get it to the attorney
